



The Palmetto Pembroke Welsh Corgi Club, Inc. Rescue Adoption Agreement

I, (we) _____,
(hereinafter referred to as ADOPTER) agree to the following conditions of The Palmetto Pembroke Welsh Corgi Club, Inc. Rescue Committee (hereinafter referred to as PPWCC) in order to adopt:

(hereinafter referred to as CORGI).

In accordance with their policies, PPWCC hereby agrees to accept return of CORGI at any time for any reason.

This agreement will be in effect as of the date below and will continue until notification to PPWCC by ADOPTER of the death of CORGI. Such notification of death, or repossession of CORGI by PPWCC, or return of CORGI to PPWCC for any reason shall be sufficient to terminate this agreement.

1. ADOPTER accepts CORGI "as is." PPWCC makes no representations or warranties concerning CORGI's health, anatomical makeup or temperament.
2. ADOPTER shall keep CORGI adequately housed indoors. I understand that the PPWCC does not adopt animals into strictly kennel or outdoor housed situations.
3. ADOPTER shall provide CORGI with a collar with identification tag or other identification showing name and address of ADOPTER and CORGI shall wear this collar at all times.
4. ADOPTER shall keep CORGI under control whenever taken off of ADOPTER'S property.
5. ADOPTER shall give CORGI all necessary vaccinations, including rabies vaccination and yearly immunizations shots (to included distemper/adenovirus 2, hepatitis, leptospirosis, parvovirus, and parainfluenza vaccine), plus an annual heartworm check and preventative heartworm medication and regular parasite checks.
6. ADOPTER shall take CORGI to a veterinarian if CORGI becomes ill. CORGI shall not be taken to an animal shelter or Humane Society.
7. ADOPTER agrees to keep CORGI on a proper diet while keeping in mind that this breed tends to gain weight in excess if not carefully monitored. Obesity may predispose CORGI to certain medical conditions and should be avoided.
8. ADOPTER agrees to notify PPWCC of any change of address or telephone number.
9. If CORGI is lost or stolen, ADOPTER will immediately notify PPWCC by telephone.
10. ADOPTER shall notify PPWCC if, under any circumstances, ADOPTER is no longer able to keep or properly provide for CORGI. ADOPTER shall not sell, give away, or otherwise transfer CORGI TO ANYONE other than PPWCC without prior notification to PPWCC.
11. ADOPTER agrees to give a donation of _____ to the PPWCC to assist in future Corgi rescue.
12. Failure to comply with any of the above shall result in forfeiture of the CORGI from the ADOPTER back to PPWCC with no monies due ADOPTER from PPWCC.

ADOPTER shall indemnify and hold harmless PPWCC, its officers and members from any and all loss, damage or expense, including reasonable attorney's fees, arising from the negligence or willful misconduct of ADOPTER or the actions of CORGI or failure of ADOPTER to abide by the terms and conditions of this Agreement. The indemnifications shall survive termination of this Agreement.
